  - iii) agree that this mandate and indemnity be governed by and construed in accordance with the laws of the Isle of Man, Jersey or England (as applicable) and that I/we irrevocably submit to the non-exclusive jurisdiction of the Isle of Man, Jersey or English courts (as applicable).
